FOOD VENDOR REGULATIONS CONTRACT

1. A representative from each vendor must check in upon arrival to Nicholson Park **BEFORE** your booth is set up. Check in is located at Nicholson city hall, 175 Lakeview Drive. **Check in time will be 9:00 am – 2:00 p.m. Friday, May 4th.**
2. All vendors must be set up and ready for business no later 4:00 p.m.
3. No one will be allowed to park in the vending area. After set up you must move your vehicle. If your vehicle is in the vending area after start of the festival you **will be ask to leave the festival immediately.**
4. All trailers over 17 ft will have to pay for 2 spaces.
5. The festival closes on Sunday at 4 p.m.
6. All vendors are subject to a jury process and reference check. Entry may be denied without reason.
7. **Vendors may only sell items approved.** Only items that you list and that are approved prior to the festival will be permitted to be sold. Be sure to list all items.
8. “Snap-N-Pops”, marshmallow guns, shooting toys, stink bombs, silly string or fireworks will not be permitted to be sold.
9. Vendors will keep the area around the facility clean and free of trash.
10. Please do not ask city employees or volunteers questions or to run errands. Please see Ronnie Maxwell or Wendy Carter for any questions.
11. No refunds of vendor fees will be given for any reason.

I have read and fully understand all the details as set forth and agree to abide by all exhibit rules and regulations, which are a part of this contract. I hereby agree to indemnify and hold harmless the City of Nicholson, personnel, volunteers or any persons participating in the Daisy Festival, from any loss, claim, penalty or lawsuit in any way arising from my operation or involvement in the festival.
